**Watkins Spur Rebuild**

The Perch Lake Township Board of Supervisors is requesting quotes for the Watkins Spur a Perch Lake Township road. This project will be done after the Watkins Spur Rebuild project.

**I. GENERAL INFORMATION:**

- a. Rebuild Watkins Spur as outlined in attached plan.
  - The relocated of buildings (sheet 5) will be completed by others and will be part of this contract
- b. The successful Contractor will:
  - Provide specifications used if quote deviates from specification.
  - Be required to provide an insurance certificate verifying general liability insurance, a minimum of \$1.5 million per occurrence. (This insurance must cover all equipment operated for the work.)
  - Have a Tax ID No. (Federal Employer Identification or Social Security No.).
  - Have Workers compensation insurance if required, under Minnesota state law.
  - Successful contractor will have to provide a bond equal to 5% of project cost.
  - Be willing to sign "Indemnification, Hold Harmless and Defend Document" if quote is accepted.
  - The work must be completed no later than August 31, 2022.
